There is a proposal in the Questar case in response to the Commission's scheduling notice issued yesterday that suggests a potential benefit to Rocky Mountain Power if we were allowed to extend our hearing on cost of capital to May 21st and move all of Questar's cost of capital case to June 30. While that the Questar case schedule is solely up to the commission and the parties to that case, we wish to make clear that the commission should consider that it will not be feasible for our case to extend to May 21st.

In the first instance we do not believe we will need, nor have we planned, to have any of our witnesses testify on May 21. Indeed our policy witness and certain of our other witnesses have conflicts on the 21st owing to the fact we interpreted the Commission's earlier order that we should conclude on May 20 so that the Questar hearing could begin May 21st.

Since there is contemplated that this proposal by Questar may benefit Rocky Mountain Power, we wish to clarify that the policy witnesses in our case simply be heard during the Revenue Requirements phase of our case that begins June 2. We are certain that for the cost of capital hearing we will be able to conclude all of the company and parties technical witnesses on May 20. As noted the Questar proposal to allow us to use the May 21 date will cause problems with our own witness schedules in place for many months.

We appreciate Questar's gesture however it comes too late for the planning we already have in place per the commission's order. The commission's witness order letter issued yesterday in this case that could permit policy witnesses to testify during our revenue requirements phase works with our planning. We have in addition to this email circulated this information to the commission's distribution list in Questar's case so all parties to both cases are informed of Rocky Mountain Power's position.
