Dear Ms. Wilson & Mr. Logan:

Well it seems that the Utah Public Service Commission has pulled a fast one on consumers again. Just when many Utahns had decided to make a substantial investment in "buying American" by switching to clean burning, American made Natural Gas for Vehicles, the UPSC decides to throw a monkey in the wrench. Why the sudden "doubling" of CNG prices when the actual cost should be around 50 cents a gallon? Could it be that you are "in bed" with BIG OIL? Or, are you just jealous that a few Utahns had made a significant investment in switching to Natural Gas for Vehicles.

Where is the incentive for Natural Gas powered vehicles now. As BILLIONS of dollars flowed out of the country last summer when gasoline was \$4.00 a gallon, some of us decided to sell our gasoline powered cars and invest a substantial amount (\$25,000 in my case) in a "dedicated" Natural Gas Vehicle.
