Dear Ms. Orchard:

In accordance with and pursuant to a request from the staff of the Public Service Commission of Utah's ("Commission") July 12, 2007 Order Selecting Area Code Overlay, and Reversing April 13, 2000 Area Code Split ("Overlay Order"), NeuStar, Inc., as the North American Numbering Plan Administrator ("NANPA") and on behalf of the Utah telecommunications industry ("Industry"), submits five copies of the planning letter for implementing a relief area code for the 801 area code.

In the Overlay Order, the Commission ordered the Industry to implement an overlay area code as the means of relief for the 801 area code. In response to the Overlay Order, NANPA facilitated a meeting of the Industry during which the Industry reviewed the Overlay Order and reached consensus to adopt an implementation schedule, dialing patterns and certain other elements of implementation. NANPA compiled this information into a planning letter and published the planning letter on its website on August 16, 2007. The Planning Letter calls for the Industry to implement the start of permissive 10-digit dialing at 12:01 a.m. Mountain Time on June 1, 2008. The end of permissive and the beginning of mandatory 10-digit dialing will begin at 12:01 a.m. Mountain Time on March 1, 2009. The earliest activation date for a central office code from the new area code is March 29, 2009. The Industry also set forth the following dialing plans:

Local calls terminating within the home area code or a foreign area code	10-digit dialing
Toll calls terminating within the home area code or a foreign area code	1+10-digit dialing
Operator Services	0+10-digit dialing

The Planning Letter, setting forth the new area code, the test CO code, the relief implementation schedule and dialing patterns, is enclosed. If the Commission should issue an order changing any of the dates within the implementation schedule, NANPA will revise the planning letter at that time.

General Description

On July 12, 2007 the Public Service Commission of Utah in Docket No. 07-999-01, rescinded and vacated their previous order to split and approved an all-services distributed overlay as the relief method for the 801 NPA. The 801 NPA serves the greater Salt Lake City area, including cities and communities such as American Fork, Bountiful, Kaysville, Morgan, Ogden, Orem, Provo, Salt Lake City and Spanish Fork. The new **385 NPA** will serve the same geographic area currently served by the existing 801 NPA. This planning letter replaces all previous planning letters mentioned above.

Implementation of Relief Plan

Implementation of the overlay of the 385 NPA is as follows:

	Time	Date
Start of permissive 10-digit dialing	12:01 AM MT	June 1, 2008
End of permissive dialing and start of mandatory 10-digit dialing	12:01 AM MT	March 1, 2009
Earliest new NPA central office code activation date	-	March 29, 2009
First date central office codes in the new NPA may be ordered through NANPA	-	September 29, 2008

During the permissive dialing period, subscribers may dial local calls within the overlay area on either a 7-digit or 10-digit basis, but will be encouraged to dial 10-digits. After the permissive period ends, all calls must be dialed using 10-digits.

When preparing for overlay area code relief, carriers are strongly encouraged to prepare their switches to begin sending 10 digits prior to the mandatory 10-digit dialing conversion date for customers.

Central Office Code Listings and NPA Map

A rate center map of the 801/385 NPA overlay is attached. An updated list of NXX codes assigned to the affected area may be found on the NANPA website at www.nanpa.com or in the

Local Exchange Routing Guide (LERG) or the NPA NXX Activity Guide (NNAG). Information in the LERG and NNAG can be obtained by contacting Telcordia Routing Administration (TRA), at 732-699-6700.

Dialing Plan

Coincident with the introduction of mandatory 10-digit dialing on March 1, 2009, the dialing plan for the 801 and 385 NPAs will be as follows:

Type of call	Call terminating in	Dialing plan
Local call	Home NPA (HNPA) or Foreign NPA (FNPA)	10-digits (NPA-NXX-XXXX)
Toll call	HNPA or FNPA	1 + 10-digits (1 + NPA-NXX-XXXX)
Operator Services Credit card, collect, third party	HNPA or FNPA	0 + 10-digits (0 + NPA-NXX-XXXX)

Network Testing

All international and domestic carriers should ensure that the new 385 NPA has been activated throughout their networks prior to start of permissive dialing. A test number to verify the routing to the new NPA will be in service beginning December 1, 2008 through June 1, 2009. The test number to verify the routing to the 385 NPA is 385-600-1234. A recorded announcement will indicate that the test call has been successfully completed.

General Information

The information in this planning letter reflects detailed information about NPA relief activities. The information has been derived from commission orders and from industry implementation decisions. The implementation of the plan described in this letter is the responsibility of individual service providers, and NANPA does not guarantee that the activities and plans will occur exactly as described herein.


