Dear Secretary Bose:

Pursuant to Section 205 of the Federal Power Act and Part 35 of the Rules and Regulations of the Federal Energy Regulatory Commission ("Commission"),¹ PacifiCorp hereby tenders for filing a Notice of Cancellation for Service Agreement No. 2 under PacifiCorp's FERC Electric Tariff, First Revised Volume No. 6 ("Service Agreement No. 2"), a requirements contract with Brigham City Corporation ("Brigham").² PacifiCorp requests that the Notice of Cancellation be allowed to become effective June 13, 2008.

1. Description of Filing

Attached hereto as Exhibit A is a Notice of Cancellation of PacifiCorp's Service Agreement No. 2, a requirements contract with Brigham, filed with the Commission on March 17, 1986, and accepted by letter order on May 13, 1986.³ Attached hereto as Exhibit B is a revised tariff sheet indicating that Service Agreement No. 2 has been cancelled.

Because Utah Power & Light Company merged with Pacific Power & Light Company to form PacifiCorp in 1989, this agreement is now referred to as Service Agreement No. 2 under PacifiCorp's FERC Electric Tariff, First Revised Volume No. 6.

2. Effective Date and Waiver

PacifiCorp requests an effective date of June 13, 2008, for the Notice of Cancellation and respectfully requests waiver of the Commission's regulations to the extent necessary to permit this effective date.

Good cause exists to permit this effective date because PacifiCorp and Brigham have entered into a new requirements agreement, under PacifiCorp's market-based tariff, that becomes effective June 13, 2008. Accordingly, no party will be prejudiced by the cancellation of Service Agreement No. 2. PacifiCorp also respectfully requests waiver of any requirement of Part 35 of the Commission's regulations that has not been fulfilled by this filing.
