

**ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF

Pursuant to Article 4.04 of the Texas Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE ONE

The name of the corporation is Transcom Communications, Inc.

ARTICLE TWO

The amendment changes the Articles of Incorporation to change the article that names the corporation. The article in the Articles of Incorporation is amended to read as follows:

The Board of Directors of the corporation unanimously adopted the amendment on December 8th, 2004. No shares of the corporation had been issued at the time of said adoption.


ARTICLE FOUR
